- 4. A consultative member consolation of the Trust is on individual who wish to support the objects and intension of the Trust various means of contribution seen as monitory time, labor, skills and professional expertise so on.

(vi) TERMINATION OF MEMBERSHIP

(a) Resigns or dies or becomes unsound of mind

- (b) By a competent court sentenced to imprisonment or any offence involving morale Turpitude Trustee.
- (c) If found by Board of Trustee to be engaged in activities which are against the interest of Trust.

(Vii) BENEFICIARIES

The beneficiaries of this Trust are members of general public of the union of India and members of international network in the world without any regard to sex. Caste persuation or religion.

(Viii) BOARD OF TRUSTEES

- 1 President of Trust shall be Sri Ramkalyan Singh S/o Late Kailash Singh Resident of Mohalla Maranpur Hanuman Nagar Town & Distt – Gaya.
- 2 The settler cum managing Trustee/secretary of the board will be Sri Manoj Kumar 'Navin' S/o Sri Ramkalyan Singh Resident of Mohalla Maranpur Hanuman Nagar Town & Distt – Gaya.
- The Treasurer shall be Smt Babita Kumari W/o Sri Aniruddh Kumar Singh At- & P.O Panwari, P.S Shikrahta, Distt Arrah.
- The remaining trustee will be Smt. Anju Singh W/o Sri Manoj Kumar 'Navin' At- Maranpur Hanuma Nagar Town & Distt – Gaya.
- Sri Awdhesh Singh S/o Late Badri Narayan Singh At P.O Panwari P.S Shikrahta, Distt Arrah.
- Smt. Bhuneshwari Devi W/o Sri Ramkalyan Singh At-Maranpur Hanuma Nagar Town & Distt – Gaya.

(IX) AIMS AND OBJECT

- (A)It Shall be purely social Cultural and non-political humanitarian voluntary welfare organization of the persons devoted to the cause of service of the mankind.
- (B) The Trust will work for the upliftment of Rural Urban and Tribal area people of all communities without discrimination of castes and creed in the field of education, health, awareness, Sanitation, development, socio-economic problem and problem of unemployment in the society.
- (C) To establish manage maintain and run different type of Technical and non-technical educational institution reading room. Common Room, library, school, college, residential public school, handicapped school, old age homes, orphanages home for the benefit of rural urban and tribal children.
- (D) To provide training to unemployed youth and girl like computer education software, typing, short hand, electronics, motor binding, lathe work, radio and T. V. making repairing for their economical development and self employment.
- (E) To organize agricultural Development programs and train farmers to grow more grain by using scientific method and provide seed, fertilizers and small machine from time to time.
- (F) To organize cultural programs music, dance, kathak dance, folk dance, classical dance etc.
- (G) To establish handicraft development centres.
- (H) To run self help group formation and training programs both in rural and urban area and train people in this field

- also to give knowledge in consumer rights, alight human rights, women empowerment, women and child labour and make people aware to eradicate terrorism from the society.
- To establish hospitals, clinics, dispensaries, health centre, veterinary hospitals, orphanages, old people home and Rehabilitation centre.
- (J) To bring about development of sources of irrigation hybrid fertilizers and to provide scientific technology for agriculture.
- (K) To promote the enter-cast, enter-religion marriage and to aware the society about to control the riots in the name of caste and religion.
- (L) To promote the Study in different aspects in Indian and local cultural songs, painting, sculpture, molding, weaving and generally art in all forms.
- (M) To make efforts to eradicate poverty, exploitation disparity, injustice, illiteracy and superstition from society.
- (N) To create opportunities of self-employment and to promote cottage industries in the village for socioeconomic upliftment of poor and the underprivileged.
- (O) To make people aware to eradicate aids, cancer, kalazar leprosy in the society and run awareness centre, and make man, woman and youth aware in this field.
- (P) It will establish and run meditation centre.
- (Q) To establish khadi Gramodyog, fishery, piggery, Dairy & Poultry farm.
- (R) To cure and rehabilitate the drug addicts.

- (S) To conduct/operate program for providing nutritional supplement program for needy women.
- (T) To undertake and work for the welfare of the mankind.
- (U) To establish educational institutes such as schools, colleges, Research institutes for the study of philosophy, logic, ontology, Debate, metaphysics, medicines history. Arts, Poetry, and other subjects but not limited to language & literature.

(X) POWER OF THE BOARD OF TRUSTEES

With the view to carry out the objects of the Trust here in above mentioned and to augment its funds and administer them in the discharge of their duties the Board of Trustees collectively shall have the following power:-

- (A) To start run or support schools colleges, training centre, hospitals, medical dispensaries and researchs centre and to take all such other steps calculated to further the cause of the providing the fulfillment of the objects of this trust.
- (B) To help and provide relief to the post backward and the down trodden in every possible way.
- (C) To make donation or contributions for the object of the trust to be realised in practice.
- (D) To receive money or any other asset, both movable or immovable in any shape or form as and when given by the author of this trust or any other persons government agencies or private bodies institution society trust and so on as a gift or donation and to hold the same as a part of the capital fund or corpus or the trust even if such persons or organization do not express their desire to so that the same or to make it available for the application to the

- furtherance of the objects of this trust treaties the same as an income of the trust.
- (E) To collect funds by donation subscription, grants, presents or contributions and other offering.
- (F) To invest the trust fund from time to time in such securities and in such manner as may be prescribes under section 13 (5) of the income tax act, 1961 for the time being in free and as amendment from time to time and to realize, invest vary and alter the same from time to time.
- (G) To acquire on lease or by purchase or other wise to sell mortgage lease out transfer in any other manner properties movable or unmovable to construct buildings and to carry out their improvements there to for the purpose of the trust and to manage and to deal with properties movable or immovable and all other assets of the trust and to pledge them to raise funds to repay loan or this trust and also to receive collect realize or cause the collection or realization or all interest dividends bonus or premium that might accrue or become due on all or any stock funds securities shares debentures and the like in which the trust funds have been invested.
- (H) Any one of the trustee duly authorized by the Board of trustees shall have the power to represent or cause to represent the Trust in all courts, lower and appellate, or before any authorities and departments or Government, semi Government. Or local
- (I) The so authorised the power to sign and verify and pleadings, memorandums of appeal, petition and applications of all kinds, to compromise, abandon, or refer

- to arbitration, the whole or part of the claim by or against the Trust, to engage lawyers, advocates, and so on and to take all such other necessary steps.
- (J) The trustee no 2 to 3 shall have the power to execute or negotiate all necessary papers, documents deeds, whether negotiable, or receive money or other assets and to grant receipts and discharges.
- (K) The trustee no 2 to 3 shall have the power to borrow for the purpose of the trust on personal credit of the trust with or without charge and responsibility upon the assets or the trust, whether from bankers or the Trust, other organizations or companies, or from private individuals, under such terms and conditions as may be agreed upon from time to time.
- (L) The trustee no 2 to 3 shall have the power to meet all the necessary expenses incurred or to be incurred in connection with creation and execution of this Trust.
- (M) The trustee no 2 to 3 shall have the power to open and maintain account of any nature in any Bank or their choice, and account so opened shall be operated by the signature of at least two of them to do all others acts, deeds, matters, and things, which may be deemed necessary for carrying out of fulfilling any or all of the objects of this trust or its administration.
- (N) The Trustee and the Board of Trustees in office at any time shall have the power delegate all or any of the powers, vested in them through these presents to the presidents and Secretary/Managing Trustee Treasurer mentioned herein, to any other Trustee or/s or any other

person/s individually or collectively for the purpose of proper and convenient management of the trust, exercising such powers. They shall reserve to themselves the power to revoke, modify, and/or abrogate any or such powers so delegated

(XI) PRESIDENT

- (A) He will preside over all meeting of the Board of Trustee and the members of the Trust in the absence of the president the members present at the meeting shall elect a president from among themselves.
- (B) He will have a casting vote which he will exercise only when there is a tie in meeting
- (C) He will Guide direct and supervise all the Activities of the society.
- (D) He will operate accounts of Trust jointly with secretary, if treasurer is not available

(XII) SECRETARY

- (A) He will look after day to day management of office of the Trust.
- (B) He will look after any, work if any specially delegated to him By Board of Trustee of members of the trust and shall be responsible for that work.
- (C) He will convene whenever necessary, meetings of the trust and of any committee which may be necessary to be called.
- (D) He will keep proper minutes of the proceedings of the meeting of the Trust and will do everything to give effect to the resolutions passed by the Board of Trustee of the Trust.;

- (E) He will make all correspondences on behalf of the Trust and keep all records.
- (F) He will responsible for the proper up keep of the accounts of the Trust.
- (G) He will submit annual progress reports and audited statements of accounts of the Trust before the board of Trust meeting.
- (H) He will be at spend for the purpose of the Trust at any time to Rs. 5,000 (Five Thousand) only without previous sanction of the Board of Trustee, which shall be approved in the next meeting.
- (I) The Trust can sue or to be sued in the name of secretary
- (J) He will whole live member and chief functionary of the Trust.
- (K) He will operate the account of Trust Jointly either with Treasurer or with President.

(XIII) TREASURER

- (A) Maintain Complete accounts of receipts and disbursement of funds in accordance with the resolutions of the Board of Trustee jointly with secretary.
- (B) Open operate, close bank accounts of any nature including fixed deposit and so on as approved by the Board of Trustee.
- (C) Be Authorised to take investments on behalf of the Trust Negotiate loans shall endorse Negotiate, or otherwise deal with all receipt, bank instruments, securities payments and so on.
- (D) He/she will receive loans, grants, donations and Subscriptions on behalf of the Trust.

(E) In general and along with the other trustee, perform all acts and functions concerning the Finance of the Trust.

(XIV) REMUNERATION OF TRUSTEE

- (A) The offices of Trustee shall be honorary and any person in the board of trustees in any capacity will not be entitled to draw any remuneration for the performance of his/her duties However they may be reimbursed for the actual expenses incurred by them while discharging their duties for the achievements of the aims and objects of the Trust as may be determined by the Board of trustees from time to time.
- (B) The Trustees shall have the power to employ any more person/persons as Trustee of this Trust, and further to delegate any power, responsibility and liability to such subsequent added Trustee/Trustees by a resolution passed by the Board of Trustees.
- (C) The powers enumerated in clause VIII of this deed shall be exercised by the Board through their attorney as the case may be subject to their satisfying the conditions laid down under Section 12A, and of the income Tax Act, 1961, as amended from time to time so that the income of the Trust will be exempted from Income tax for each and every assessment year, and the donations made to it by the general public are eligible for deduction under Section 80 G of the Income Tax Act 1961, for the time being in force.

(XV) LEGAL ADVISOR

As per requirement.

(XVI) MEETING OF BOARD OF TRUSTEES

- i) The Board of Trustees shall meet from time to time at least four times a year. These will be termed ordinary meeting.
- ii) The Secretary may also convene extra ordinary meetings as and when required for the transaction of the business of the Trust and its betterment. Notice for all ordinary meetings of the Board of Trustees will be sent by the Secretary to each notice will contain the agenda of Business to be transacted.
- iii) Notice for all extra ordinary meetings of the Board of trustees will be sent to each Trustee a minimum of twenty four hours prior to it. Those unable to attend because of information and approval.
- iv) The quorum for the meeting of the Board of Trustees shall be one third of the total number of the Trustees of the Board.
- v) When there is no quorum for meeting at its scheduled time, the Founder/Managing trustee or Secretary may adjourn the meeting for a suitable duration.

(XVII) GENERAL MEMBERSHIP MEETING.

- The trustee and also consultative Members of the Trust meet at least once a Year. This meeting will be termed general meeting.
- ii) The Secretary will convene general meeting on appropriate occasion after consultation with the president.
- iii) Notice/Announcement for general Meeting will be made and sent by the Secretary through newsletter of the Trust

of any other appropriate means at least one month before the scheduled meeting.

(XVIII) AREA OPERATION

The present area of operation should be Bihar state and may be extended to other parts of India.

(XIX)BANK ACCOUNT

The Trust will be open Bank Account in any Bank. The bank account will be jointly operated as above mention.

(XX) FIVE CATEGORIES OR THE TRUST FUND

The Trust fund shall be built by donations contribution and all other source of Income and shall be categories in the following five ways (the colours of lotus) accordingly to intentions natures and purposes of the object of the Trust.

ii	Spiritual fund	(White lotus flower)
iii	Welfare fund	(Red lotus flower)
iv	Educational fund	(Yellow lotus flower)

v Development research and investigation fund. (Blue lotus flower)

The Trust will monitor build and distribute all its FUNDS
in accordance with alone mentioned Five specified
categories of the Trust Fund in order to fulfill the objects
of the Trust and the intentions of donors and contributions
in particulars.

(XXI) ACCOUNTS & TAX RETURNS

- i) The Treasure with the help of the secretary shall maintain or cause to maintain proper and correct books of accounts in respect of all the sums of money received and paid spent, invested on behalf of the Trust, and all its assets movable and immovable liabilities and so on.
- ii) The books of accounts so maintained and the balance sheet at the last date of every financial year shall be audited by qualified chartered Accountant.
- iii) The secretary and Treasurer together will be responsible for filing income tax returns within the stipulated period every year.

(XXII) AMENDMENTS TO THIS DEED

The Board of Trustees shall have the power from time to time to make or alter such rules and regulations with regard to the conduct of this Trust to such an extent and in such a manner as they may deem fit subject to the conditions and they shall not be inconsistent with the objects as set in these presents by way of resolution.

(XXIII) INDEMNIFICATION

The Board Trustees individually shall indemnified against any expenses and losses incurred or suffered or any payment made by them in good fait in the administration of the Trust and such expenses losses and payment shall be borne by the Trust and none of the Trustees shall be personally liable or responsible for the same.

(XXIV) EXTINCTION OF THE TRUST

The Trust may be extinguished at any time with the consent of the Board of Trustees under the provision of Indian Trust Act. 1882 upon extinction of the Trust the entire Trust fund shall be realised and first used for the payment of liabilities of the Trust and for meeting the expenses of Realisation the balance left if any shall be donated to such institutions or Trusts having similar objects as this Trust is and is registered under 12 A of the Income tax Act. 1961 for the time being in force.
